

This End User Licence Agreement sets out the terms and conditions between Hello Table Pty Ltd, the owner of the recipeezi Gluten Free smartphone application (**Gluten Free App**) and you, the user of the Gluten Free App. These terms and conditions apply to the way in which you can download, install, access and operate the Gluten Free App.

In order to access the Gluten Free App you must first have registered and created an account with us. By doing so, you agree to the terms and conditions of this agreement.

Access to or use of the Gluten Free App shows your acceptance of these terms and conditions. If you do not agree with them, you must not access or use the Gluten Free App.

### **User account**

You must be at least 18 years old to create an account and access the Gluten Free App.

When you create your account, you will have to provide us with your name, email address and a password. You will need these to access and use the Gluten Free App.

You will be solely responsible for all access to and use of the Gluten Free App by anyone using your password and user name whether or not such access to and use of the Gluten Free App is actually authorised by you, including without limitation, all communications and transmissions and all obligations (including without limitation financial obligations) incurred through such access or use.

You are solely responsible for protecting the security and confidentiality of your user name and password. You must immediately notify us of any unauthorised use of your user name or password or any other breach or threatened breach of the Gluten Free App's security.

### **Subscription and payment**

In order to subscribe to the Gluten Free App you will be required to provide your credit card information via the relevant App Store. If you have any issues with payment do not hesitate to contact us at [hello@hellotable.com.au](mailto:hello@hellotable.com.au).

You are entitled to a 30 day free trial of the Gluten Free App. After the end of the 30 day free trial or any other promotional trial, discount, offer or coupon has ended, your subscription will automatically rollover to full-priced monthly membership unless it has been cancelled before the end of the free trial or promotional period. The following month's fees and charges will be charged to your nominated payment method. Any unused portion of your free trial, will be forfeited if you purchase a subscription to the Gluten Free App before the free trial has concluded.

The subscription fee will be as set out on the App Store at the time you first register for the Gluten Free App.

Your subscription is paid on a monthly basis and will automatically renew, unless auto-renew is turned off at least 24-hours before the end of the billing period. Your account will be charged for renewal within 24-hours prior to the end of the billing period.

We reserve the right to vary the subscription fee from time to time but any variation will only take effect after we have given you at least one month's notice of any such variation.

If you do not agree to the variation, you may cancel your subscription by giving us at least 24-hours' notice before the end of the subscription billing period. If you do not cancel your

subscription before the end of the subscription period, you will be deemed to have accepted the variation.

All prices are in AU dollars unless otherwise stated and inclusive of GST.

All payments made through iTunes or Google Play are controlled and managed by Apple or Google respectively. Payments will be charged to your iTunes or Google Play Account at confirmation of purchase.

You may manage or cancel your subscription by going to your iTunes or Google Play account settings after purchase. If you choose to cancel your subscription, you will continue to have access to our App until the end of your monthly billing period.

You must notify us of any change to your billing account. If any subscription fees or charges billed to your account, are not processed for any reason, then we have the right to suspend or cancel your subscription until all fees and charges have been paid in full. Any discount given to you in the early periods of the release of the Gluten Free App cannot be guaranteed to continue if your account lapses or is cancelled for whatever reason.

You agree to pay all costs, including legal fees on a full indemnity basis, which we incur in collecting any unpaid subscription fees or charges from you.

Subscription fees will apply regardless of whether or not you use your subscription. Except as otherwise required by law, no refunds will be given for subscription fees for unused periods of your subscription in the even you decide to terminate your subscription.

Whilst we do our best to ensure the Gluten Free App is available at all times, if access to the Gluten Free App is delayed or unavailable for a prolonged and continuous period, we will give you credit for the time that the Gluten Free App is unavailable. In other instances, we may still charge your account.

### **The licence**

We grant to you a non-exclusive, non-transferable licence to download, install, access and operate the Gluten Free App on any approved smartphone, tablet or other similar mobile device (**Device**) that you own or control and as permitted by the manufacturer or supplier of the Device.

You must not:

- (a) sell, resell, rent, lend, license, transfer, redistribute or sublicense the Gluten Free App;
- (b) make the Gluten Free App available over a network where it could be accessed and used by multiple devices at the same time;
- (c) copy, alter, modify, adapt, reproduce, republish, frame, translate, disassemble, reverse engineer, decompile, create a derivative work from or enhance the Gluten Free App and/or any content in the Gluten Free App (except as expressly permitted by this agreement or other applicable law);
- (d) use the Gluten Free App so that it infringes our rights or the rights of third parties;
- (e) take any steps to circumvent any technological protection measure or security measures in the app; or
- (f) authorise anyone else to do any of the above acts.

This agreement will apply to any upgrades provided by us for the Gluten Free App unless the upgrade has its own agreement in which case the terms of that agreement will apply.

We reserve the right to alter, update, or remove the Gluten Free App or any part of it at any time. We may conduct such modifications to the Gluten Free App for security reasons, intellectual property or other legal reasons, or various other reasons at our discretion.

### **Use of data**

We may collect and use data including information about:

- your average duration of sessions
- number of times a day the Gluten Free App is opened
- screen views per visit
- event tracking
- time of day/week the Gluten Free App is opened
- the popular recipes
- the most common ingredient added to the shopping list
- source of link to Gluten Free App – where you came from search, social media, website, other.

You agree that we own this data and can use it for any purpose, including for commercial purposes, provided that it does not personally identify you and any use is in accordance with the consent you have given to us under our [Privacy Policy](#). [\[link to the Privacy Policy\]](#)

### **Intellectual property**

We are the owner or licensee of all intellectual property rights including copyright, trade marks, patents, inventions and designs, whether registered or unregistered, and all rights of a like nature, in the Gluten Free App and the content you access when you use the Gluten Free App. You have no rights to reproduce, re-publish or do any other acts with the Gluten Free App or the content except for those rights granted to you under this agreement. You must not do anything that does or might invalidate or be inconsistent with our intellectual property rights.

### **User generated content**

We are not responsible for any information or data uploaded to the Gluten Free App by you or any other person. You give us an irrevocable, non-exclusive, royalty-free, worldwide, transferable, sublicensable licence to use any content that you provide to us via the Gluten Free App, or anywhere we deem appropriate for our business purposes.

We are not responsible for the content of any communications you receive from another user of the Gluten Free App which is the result, whether direct or indirect, of your use of the Gluten Free App.

### **Termination**

This agreement will remain in force until terminated by either you or us. Your rights under this agreement and your ability to access and operate the Gluten Free App will terminate automatically and without notice if you cease to be a registered account holder with us or if your account is suspended or terminated in accordance with this agreement.

We may immediately terminate this agreement at any time if we discontinue providing the Gluten Free App or any computer server or website required for the intended operation of the Gluten Free App.

If this agreement is terminated for any reason, you must immediately:

- (a) cease to use the Gluten Free App; and
- (b) delete all copies of the Gluten Free App in your possession or control.

On termination, we may delete all electronic records created while you used the Gluten Free App.

### **Apple Inc and Google Inc**

We and you each agree that Apple Inc (**Apple**) and Google Inc (**Google**), and Apple's and Google's respective subsidiaries, are third party beneficiaries of this agreement, and that, upon your acceptance of the terms and conditions of this agreement, Apple or Google, whichever is applicable, will have the right (and will be deemed to have accepted the right) to enforce this agreement against you as a third party beneficiary of this agreement.

Your use of the Gluten Free App may also be subject to terms and conditions of use which were accepted when you set up your account with Apple or Google.

## **General**

If part or all of any of this agreement is illegal or unenforceable it will be severed from the agreement and will not affect the continued operation of the remaining provisions of the agreement.

We reserve the right to amend this agreement at any time. We will give you reasonable notice before any amendments come into effect. Your continued use of the Gluten Free App will be deemed to constitute your acceptance of the amended agreement. It is your responsibility to ensure you are familiar with the most recent version of this agreement prior to each use of the Gluten Free App. You can do this by checking the terms of this agreement when you are logged into the Gluten Free App where information on changes and the new version of this agreement will be available.

This agreement is governed by the laws of Victoria and the parties irrevocably and unconditionally submit to the exclusive jurisdiction of the courts of Victoria.
